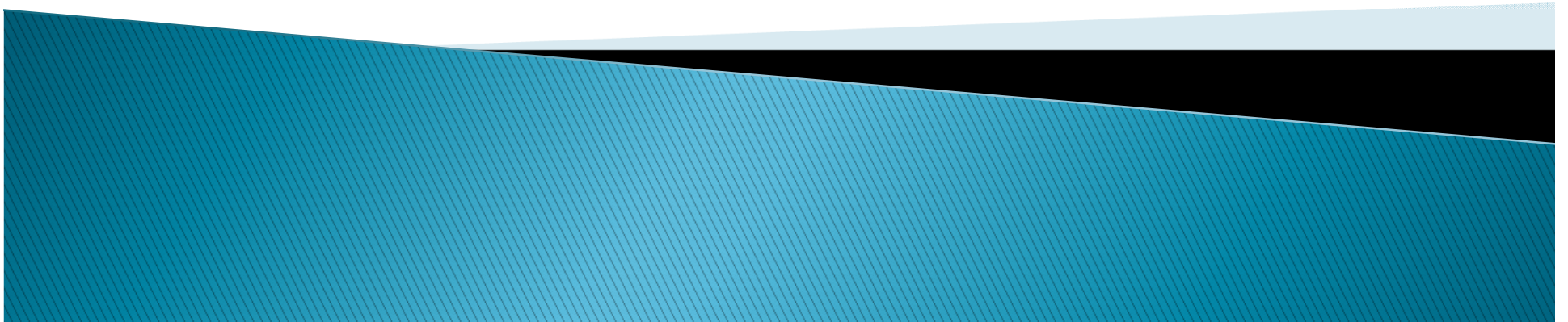

# Assembly – 1741

- ▶ Sponsor – Tedisco
- ▶ 1 / 6 / 16– Referred to Gov't Ops.
- ▶ Amends executive law; creates a state emergency assistance database (DPC responsible) \*Requires, rather than authorizes, county governments to maintain a registry of disabled persons, to include elderly persons.



# Assembly – 2200 / Senate 2244

- ▶ Sponsor – Weprin
- ▶ 1 / 6 / 16– Ordered to 3<sup>rd</sup> Reading
- ▶ Establishes an emergency evacuation plan for individuals with disabilities, who live in a high-rise building, establishes a \$500 fine for failure to comply.



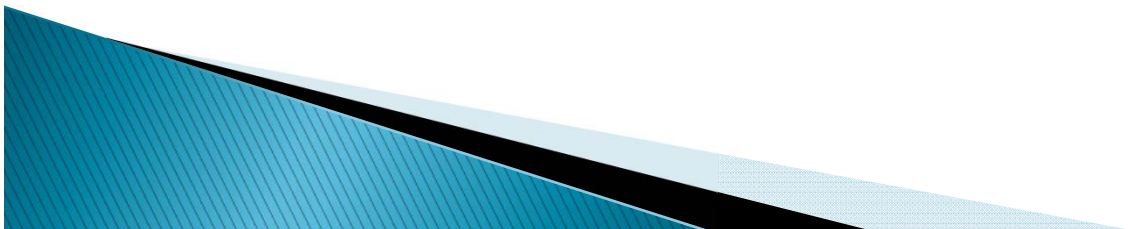
# Assembly – 3175A

- ▶ Sponsor – Rosenthal
- ▶ 2/16/16– Amend and Recommit to Gov’t Ops.
- ▶ Establishes “emergency preparedness month act: and exempts pre-fabricated go-bags and individual emergency preparedness items from sales tax during specified time periods.



# Assembly – 4145

- ▶ Sponsor – Kearns
- ▶ 1 / 6 / 16– Referred to Ways and Means
- ▶ Provides a credit for general volunteer services performed and hours expended during a federal disaster or emergency.



# Assembly – 2726

- ▶ Sponsor – Peoples–Stokes
- ▶ 1 / 6 / 16 – Ordered to 3<sup>rd</sup> Reading cal. 125
- ▶ Would require nursing homes, assisted living centers and Dialysis centers to have emergency generators available as part of their disaster preparedness plans.



# Assembly – 5348

- ▶ Sponsor – Cusick
- ▶ 1 / 6 / 16 – Referred to Gov't Ops.
- ▶ Establishes an executive statewide plan for natural disaster emergency procedure; allows state and local officials to act cooperatively and efficiently; provide public with clear, concise and effective set of guidelines for how to prepare for disasters.



# Assembly – 5586

- ▶ Sponsor – Cymbrowitz
- ▶ 1 / 6 / 16 – Referred to Health
- ▶ Formulates and implements a statewide plan for evacuation and disaster and emergency preparedness plans at nursing homes and assisted living facilities; requires inspections of such facilities.





# Assembly – 6990

- ▶ Sponsor – Glick
- ▶ 11 / 20 / 15 – Signed Chap.444
- ▶ Enacts the “Veterinary Emergency Response and Mobility Act of 2015”. Provides for licensing exemptions for specially trained, out-of-state veterinarians, under specific circumstances related to natural disaster response and high-volume animal cruelty investigations.



# Assembly – 8651

- ▶ Sponsor – Kearns
- ▶ 1 / 7 / 16 – Referred to Gov't Ops.
- ▶ Authorizes chief executives to designate any vehicle as an emergency vehicle during a declaration of a disaster emergency.
