


What is a VOAD?







Areas of Concern:

- 33 out of 62 Counties do not have a COAD/VOAD
 - County vs. Community/Neighborhood COADs
- Lack of understanding and use of NVOAD Points of Consensus & Guidelines
- Lack of funding for building and sustaining COAD/VOADs
- Managing the 3rd Evacuee/Displacement Disaster (Katrina, Haiti, & Maria)
 - No Model
 - No Funding
- Contract period prior to DCMP, DMH and Rebuild
- SSBG Grants not coordinated with local VOADs members & NVOAD POC
- NVOAD is now operational competing with States for DCMP & Repair Contracts
- No NYS or Region II Recovery Fund
- Regional Catastrophic Events (Gotham Shield)





2017-2018 Evacuee Response:

- 2,200 FEMA IA Registrant Households in New York State
 - 1350 Households (60%) in NYC
 - 3000+ have been through the NYC Hurrican Evacuee Service Center
 - Average Family Size, 3
- 17,000 Estimated Individual Evacuees State-wide
 - 60% Claim to want to permanently stay
- 90% have no resources to return or secuire sustainable housing
- Pending National DCMP (Florida & NY)

Puerto Rico & U.S. Virgin Islands Evacuees in New York February 5th, 2018

In September 2017 Hurricanes Irma and Maria left a trail of destruction through the Caribbean. The U.S. territories of Puerto Rico (PR) and the U.S. Virgin Islands (USVI) sustained significant damage, causing many to evacuate to the continental United States (CONUS). Significant infrastructure issues persist; the U.S. Army Corps of Engineers estimates that <u>full power restoration</u> will occur by May 2018.






